Intellectual Property License Agreement for Musical Compositions and/or Texts

This Agreement is made as of _____, by and between (Full legal name as it appears on Submission Form) _____

(hereinafter the “Licensor”) located at _____

and Treasury of Sacred Music®, Inc. (hereinafter the “Licensee”), located at 611 Eden Circle, Eagan, Minnesota 55123.

1. Purpose

Licensor owns intellectual property consisting of original musical compositions and/or texts for said compositions and grants Licensee rights to distribute them to Licensee member subscribers under the terms of a Member Subscriber Agreement.

2. Licensed Work

The Licensor’s copyrighted, intellectual property is entitled: _____

The composition may include text, melodies, arrangements, and any related sheet music or recordings.

3. Grant of License

Licensor grants Licensee a non-exclusive, revocable, royalty-free license to display to the general public and to distribute the licensed work worldwide to its Members under the terms of a Member Subscriber Agreement in perpetuity, unless terminated earlier under Section 7.

4. Restrictions

Licensee shall not alter the licensed work without written consent; claim authorship or ownership; or use the licensed work in ways that violate applicable laws or moral standards

5. Ownership

Licensor retains full ownership of licensed work. Licensee acknowledges no transfer of ownership.

6. Attribution

Licensee shall credit Licensor as follows: “_____, composer” and/or
“_____, text writer” in all public uses, recordings, and published materials.

7. Termination

This Agreement may be terminated by either party with 30 days’ written notice or immediately upon breach. Upon termination, Licensee shall cease use and destroy or return all copies.

8. Representations & Warranties

Licensor represents that they are the sole creator or authorized rights holder of the licensed work; that said work is not the product of artificial intelligence or any other form of virtual generation; that the licensed work does not infringe on any third-party rights; and that all samples or interpolations (if any) are properly copyrighted. 9. Indemnification

Licensor agrees to indemnify, defend, and hold the Licensee harmless from any claims, damages, or legal actions arising from allegations of plagiarism or copyright infringement related to the licensed work, provided Licensee has not altered the licensed work or used the licensed work outside the scope of this Agreement.

10. Successors and Assigns

This Agreement shall be binding upon and inure to the benefit of the parties hereto and their successors and assigns.

11. Force Majeure.

The Licensee is free of liability to the Licensor where the Licensee is prevented from executing its obligations under this Agreement in whole or in part due to Force Majeure, such as earthquake, typhoon, flood, fire, war, pandemic, or any other unforeseen and uncontrollable event where the Licensee has taken appropriate action to mitigate such an event.

12. Governing Law

This Agreement shall be governed by the laws of the State of Minnesota.

13. Entire Agreement

This document represents the entire agreement and supersedes prior communications.
